

MARA NORTHEAST

HISTORY

THE BEGINNING – 12 OCTOBER 1995

Richard (Dick) Rostrum NG2R was the MERCURY AMATEUR RADIO ASSOCIATION (MARA) Director (appointed by K8ES) on the east coast and was the driving force behind the October 12th, 1995 informal meeting in Washington (Rockville MD) at the Woodfin Suites to see if there was sufficient interest in establishing a MARA group in the northeastern area of the Church. By this time MARA, based in Salt Lake City UT, previously tasked with providing the Church's emergency communications, but now no longer with a mandate from the Church, was disbanding and those involved had no further interest in directing the organization.

At the informal meeting, it was decided that there was sufficient interest to hold a second meeting. It was agreed that a constitution and bylaws would be introduced, discussed and voted upon, and that an executive and a board of directors would be elected.

THE FORMATION MEETING – 29 MARCH 1997

At the March 29th 1997 meeting, hosted by Chic WA2USI, at the Cherry Hill Ward chapel in Cherry Hill, NJ, several examples of constitutions and bylaws were viewed and discussed. The one submitted by Dick NG2R was, after some discussion and modification, accepted by the group. It was decided that we call ourselves the Mercury Amateur Radio Association – North East or MARA NE. Dick was elected the first president.

Vice President – Dan Janda AA3LS	(two years)
Secretary/Treasurer – Dave Marling VE1VQ	(two years)

3. Charles (Chic) Naylor WA2USI	(four years)
4. Rulon Van Dyke KA7BCD	(four years)
5. Hal Christensen W4VC	(six years)
6. Jeff Lawson KD1WZ	(six years)

The terms of office were staggered so that not all executive and directors would have to be re-elected at the same time.

Jeff KD1WZ was appointed newsletter editor.

Art W1OND was appointed net manager.

Chic WA2USI accepts a six year term as director.

Dave Smith NQ1H accepts a six year term as director and the assignment as newsletter editor.

Chic WA2USI re-offers and is accepted for another two year term.


STROUDSBURG, PA – 10 JUNE 2006

The meeting was held at the Nautilus Diner in Crofton, MD. Prior to the formal meeting some individuals met at the DC Storehouse.

The \$5 annual dues were dropped.

The MARA NE Constitution Preamble was amended as follows:

We, the Membership, wishing to secure for ourselves the pleasures and benefits of an association of persons in the LDS Church or otherwise commonly interested in Amateur Radio and in developing and maintaining emergency communications skills, constitute ourselves the Northeast Mercury Amateur Radio Association (hereafter known as "the club") and enact this constitution as our governing law. It shall be our purpose to further the exchange of information and cooperation between members; to promote radio knowledge, fraternalism and individual operating efficiency; to conduct programs and activities to advance use of Amateur Radio for emergency communications; and to provide training, support and encouragement for those who would serve in emergency communications.

Therefore further, be it resolved that the MARA-NE constitution "Article I – Membership" be amended as follows:

All persons interested in providing emergency communication services by Amateur Radio shall be eligible for membership. Membership shall be by application and election upon such terms as the club shall provide in its By-laws.

Dave, VE1VQ, was thanked for his contribution to the MARA NE with the following resolution:



Bruce, N3IA, selected to fill in for Bob, N3TS.


NO MEETING WAS HELD IN 2016
